- i. Application No: DC/18/04250 The Millstone, Long Thurlow Road Sub Divison of existing dwelling to form 2no. Dwellings incorporating a 2 storey & single storey rear extension, porch, internal & external alterations: Council discussed all in agreement no objection subject to acceptable parking which meets the requirements of Suffolk Highways and as long as heritage is supportive of the extension due to the proximity of listed buildings.
- ii. Application No: DC/18/04324 The Coach House, Ashfield Grange, Long Thurlow Road Erection of extension to cartlodge/garage for workshop & storage: Council discussed all in agreement no objection.

- iii. Application No: DC/18/04506 Land to the South of Lea Lane Change of use of land for the siting of 32no. 20' self-storage containers and 8no. 40' self-storage containers:
 Council discussed vote carried out 2 object 3 no objection (chairman's vote) subject to the following comments:
 - Highways must consider increased traffic implications on a small rural village.
 - Highways must be happy the junction has sufficient visibility for increased numbers in traffic.
 - Highways must be happy this will not increase accidents in an area already prone to road traffic incidents.
 - Daylight use only.
 - If there has to be lighting only movement sensor lighting only, no security lighting as a rural location.
 - Containers should be a suitable colour to blend into the environment e.g. green.
 - No outside storage.
 - To be used for self-storage only as per the application with no commercial storage.
 - To ensure adequate screening using native hedging and trees.
 - To ensure this will not impact on this heritage site of farmhouse, moat and airfield.
